Her pay is fixed at Rs.35400/- per month in Pay Matrix Level-06 plus usual allowances as admissible from time to time.

Her appointment is subject to the following conditions:-

- 1) She will be on probation for a period of 2 years from the date of appointment. She has to undergo the mandatory initial training prescribed for Commercial Clerks. She will be absorbed regularly as Chief Commercial Cum Ticket Supervisor in Pay Matrix Level-06 only after successful completion of the above training course.
- 2) Her service is purely temporary and she will not be entitled to any notice of termination of service or pay in lieu thereof if such termination of service is due to expiry of the officiating capacity/vacancy or due to removal or dismissal as a disciplinary measure after compliance with provisions of clause (2) of 311 of the Constitution of India. Otherwise, her services will be terminated on 14 days notice on either side.
- 3) In terms of Railway Board's letter No.2004/PC11/21/1 dated.10.01.04, she is coming under the Contributory Pension Scheme. All the new recruits in the Central Government Service joining Government Service with effect from 01.01.04 shall compulsorily make contribution to the Government. The contribution payable by the Railway servants towards

Tier I will be recovered at the rate of 10% of Basic pay and DA from their salary every month. In addition to above pension account, each Government servant may also have Tier II withdrawal account at their option.

- 4) Her salary will be claimed through Nationalized bank.
- 5) Her appointment is purely provisional subject to the recruitment verification reports received from Civil/Police authorities regarding her character and antecedents. If anything adverse is found in the report regarding her suitability for appointment in Government Service, she is liable to be terminated summarily.
- 6) She will be responsible for the money/goods/store and all other properties entrusted to her. She must refund/reimburse any payment including salary, arrears of pay etc, if paid to her in excess of her entitlement, when detected later. The Railway administration is authorised/ permitted to recover such overpayments if any, from her salary or other sources of payment including terminal benefits.
- 7) All other conditions are as stipulated in this office offer of re-appointment.
- 8) HRMS Number & PRAN No. assigned should be quoted in all correspondence.
- 9) Her date of joining/taking independent duty may be advised to all concerned in time.
