

उनकी नियुक्ति निम्नलिखित शर्तों पर निर्भर है/Their appointment is subject to the following conditions:-

- 1) वे नियुक्ति की तारीख से दो साल के लिए परीक्षा पर होंगे। They will be on probation for a period of 2 years from the date of their appointment. They are to undergo the mandatory initial training prescribed for Commercial Clerks. They will be absorbed regularly as Senior Commercial Cum Ticket Clerk in Pay Matrix Level-05 only after successful completion of the above training course.
- 2) उनकी सेवा बिल्कुल अस्थायी है और वे किसी तरह की सेवा समाप्ति सूचना या उसके बदले वेतन के लिए अर्ह नहीं है यदि ऐसी सेवा समाप्ति स्थानापन्न हैसियत/रिक्ति की समाप्ति या भारतीय संविधान के 311 के उपबंध (2) के प्रावधानों के अनुपालन के बाद अनुशासनिक तौर पर निकाले या बर्खास्त किए जाने के कारण है। अन्यथा उनकी सेवाएं दोनों तरफ से 14 दिन की सूचना पर समाप्त की जा सकती है। Their service is purely temporary and they will not be entitled to any notice of termination of service or pay in lieu thereof if such termination of service is due to expiry of the officiating capacity/vacancy or due to removal or dismissal as a disciplinary measure after compliance with provisions of clause (2) of 311 of the Constitution of India. Otherwise her services will be terminated on 14 days' notice on either side.
- 3) Their appointment is purely provisional subject to the recruitment verification reports received from Civil/Police authorities regarding their character and antecedents. If anything adverse is found in the report regarding their suitability for appointment in Government Service, they are liable to be terminated summarily.
